If hard copy is allowed then a complete set of Bidding Documents may be purchased from the office Dharmadevi Municipality Sankhuwasabha Shankhuwasava and the office Dharmadevi Municipality Sankhuwasabha Shankhuwasava by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NRs.3000.0 till 22-10-2024 12:00 during office hours.

6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 22-10-2024 13:00 at the office of Dharmadevi Municipality, Sankhuwasabha, Koshi Pradesh Nepal. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of Rs. 46830, which shall be valid for 30 days beyond the validity period of the bid (i.e. [Refer Clause ITB 20.1]). If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No. [41325240600010] at [Nepal SBI Bank Ltd., Sankhuwasabha, Dharmadevi Branch, Koshi Province] and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
